Networking and communication

- Take a lead role in developing and maintaining strong relationships with civil society in areas of responsibility
- Work proactively with civil society in areas of responsibility to identify opportunities for and support
 organic processes of collaboration and networking between civil society groups and other actors
 and support them to develop their analysis of issues, key players and potential resources
- Under the guidance of the Programme manager, identify and build relationships with other national and international actors working to support civil society in Rakhine and look for areas of potential collaboration
- Provide a point of reference and interface between local organisations in areas of responsibility and Oxfam / other organisations' technical support capacity
- Communication and coordination with civil society groups in areas of responsibility to facilitate sharing of information useful to those groups
- Support the dissemination of good practice internally and externally (either directly or in an advisory capacity to partners and networks)

Direct influencing

 Take a lead role in context analysis in area of responsibility to contribute to advocacy and influencing strategy

- Under the guidance of the Civil Society Strengthening in Rakhine Programme Manager, identify
 opportunities to work with external stakeholders to promote the profile, independence and role of
 civil society actors in Rakhine
- Support the generation of evidence and learning that enables effective influencing with donors, INGOs, Rakhine State Government and Government of Myanmar
- Actively communicate and share learning and programme innovations to the wider Oxfam Myanmar programme

Programme Management

- Assist the Programme Manager in all areas of work, including effective monitoring and evaluation efforts, financial monitoring and report writing
- Assist in tracking programme activities to contribute to the outcome harvesting
- Assist in keeping track of changing context as well as progress markers
- Ensure that budgets are drawn up for all programme activities
- Support further programme development and fundraising efforts as required

Capacity building
