The project will also support to strengthen

livelihood activities at community level to enhance their resilience.

The post holder will be responsible to implement the project with a strong focus on enhancing resilience of livelihood of the communities living under threat of disaster and conflict through extending technical and financial support and enhancing their capacity to

bounce back quickly in the event of disaster.

KEY RESPONSIBILITIES:

- Ensure effective and efficient implementation of the project activities related with livelihoods within the targeted timeframe and agreed objectives
- Analyse food security & livelihood situation in a disaster context and ensure effective implementation of Food Security and Livelihood Work by working closely with local community and partner organisation in the selected programme areas.
- Lead community mobilisation process and design, plan, and implement livelihood activities from DRR perspective.
- Provide technical support in implementation of livelihood activities such as cash transfer programme, agriculture (crops livestock), fisheries and other skill based intervention that are context specific with focus on consumption and market
- Build synergy between livelihood interventions with DRR and resilience building works.
- With the support of the Programme Manager, develop detailed work plan in line with the project's objectives and expected outcomes.
- Coordinate with relevant government departments, village track and community to undertake a joint assessment
 of livelihood activities, vulnerability and planning a comprehensive livelihood plan in a disaster prone local context.
- Explore the gap analysis and identify capacity development needs related to DRR of local government agencies, village track and other relevant stakeholders
- · Be responsible to support livelihoods related capacity building initiatives to the local partner

- Lead organizing capacity building initiatives for target communities and partner organisation on finetuning livelihood interventions in a disaster context.
- With the support from Programme Manager, work closely with local government officials in advocating support for resilient livelihood initiatives and its scaling up.
- Participate in project impact assessment (at project completion stage)
- Participate in preparedness and capacity building initiatives of Oxfam humanitarian team
