Construction of 01 Pawor Host Community Water Supply System in Arua District

1. The Government of Uganda (the Recipient), represented by the Office of the Prime Minister (The Project Executing Agency) received a grant from the Government of the Federal Republic of Germany, represented by German Federal Ministry of Development and Economic Cooperation (BMZ) through KFW, in the amount of **Euro 10 Million** towards the cost of the Refugee Response Fund. RRF is partly implemented by **Oxfam** Germany. Oxfam Germany (the Implementing Agency) intends to apply part of the fund to cover eligible payments under the lumpsum contract **TD 18/ 004 / ARU-UG** for **Construction of Pawor Host Community Water Supply System in Arua District**.
2. Oxfam Germany now invites sealed bids from eligible and qualified bidders for **Lump Sum Contract TD 18/ 004 / ARU-UG for Construction of Pawor Host Community Water Supply System**
3. The construction period is: **4 months** from the start date.
4. Bidding will be conducted through the National Competitive Bidding (NCB) procedure specified in the KFW Procurement Guidelines (*Guidelines for the Procurement of Consulting Services, Works, Plant, Goods and Non-Consulting Services in Financial Cooperation with Partner Countries* 2016) , and is open to all bidders from Eligible Source Countries as defined in the Bidding Documents.

5. Interested eligible bidders may obtain further information from Oxfam Uganda and inspect the Bidding Documents at the address given below from 09.00 – 12.00 hours and 14:00 to 16.00 hours East African Time from Monday to Friday.

6. **Qualifications requirements include:**

- a. **Minimum average annual construction turnover** for the last three years shall be: **Uganda shillings 1.5 Billion.**
- b. The Bidder must demonstrate **access to, or availability of, financial resources** such as liquid assets, lines of credit and other financial means, other than any contractual advance payments for the amount as below: **Uganda shillings 250 million. Evidence shall be consistent bank balances or unconditional bank loan offer.**
- c. Participation as contractor, management contractor, or subcontractor, in **at least one (1) contract within the last five (5) years (Since 1st May 2014), with a value given below**, that have been successfully and substantially completed and that are similar to the proposed Works:

Uganda shillings 800 million

The similarity of works shall be based on the physical size, complexity, methods/technology as explained under Sections VIII, IX and X of the Bidding Document.

- d. **Personnel:** The Bidder must demonstrate that it will have the personnel for the key positions that meet the following requirements:
- “a **Contract Manager** Bachelor's Degree in Civil Engineering with 10 years' experience in water system designs, project management and contract management; and a **Site Engineer** Bachelor's Degree in Civil Engineering with 05 years' experience in water system designs, project management and contract management.”
- e. **Equipment:** The Bidder must demonstrate that it will have access (owned/rented/leased) to the key contractor's equipment listed hereunder (evidence shall be certificate of ownership or signed lease or rental agreements specific to this tender):

8. **Bids must be delivered and received** in hard copies, **sealed** to the **address below** on or before **Wednesday, 26th July 2019** by (1200Hrs); **East Africa Time**. Electronic bidding **shall not** be permitted. Late bids will be rejected. **Bids shall be opened** physically, immediately after bid submission deadline, in the presence of the bidders or the bidders' representatives who choose to attend in person, at the same location as for bid submission.
